Merchandise warehoused at the port of original importation, or rewarehoused at another port under a transportation bond, can be withdrawn only upon an entry, signed by the party or firm warehousing or rewarehousing the same, or by the person duly authorized in writing upon such entry by such party or firm, in accordance with Article 50, Forms 12 and 13, Revised Regulations. The failure in business of the original importer cannot affect the lien of. the United States for the duties which accrued by the importation, nor the acceptance of such duties from any person legally authorized to withdraw the same; but authority merely to enter and bond does not include authority to transfer; that must appear in express terms by a power of attorney, duly executed and proven, and filed with the withdrawal entry.--(Letter to Coll. Customs, Norfolk, Va., May 21, 1869.)...
