

Where there exists a white and colored local in any city, they shall elect representatives to meet at least twice a year to equalize the scale of wages and conditions of employment of the craft. Sec. 97. Any local not being represented at meetings of the Local Joint Executive Board twice in succession shall be fined the sum of 5, same to be paid by local into the funds of the Local Joint Executive Board. Further provided, that should any local in any city neglect to have a representative in attendance at the Local Joint Executive Board meetings they should be punished as provided in Section 85. DISTRICT AND STATE BRANCHES. Sec. 98. (a) A District or State charter shall be granted to any District or State where more that onehalf of the locals in said District or State shall petition the General Executive Board for same. When such District or State charter is granted as above, it shall be mandatory upon each and every local within the jurisdiction of such District or State Branch to affiliate with same, and to qualify as prescribed by the Constitution and By-Laws which may be adopted by such body when duly chartered, provided that such Constitution and By-Laws do not conflict with the International Constitution and are approved by the International President.
